#### **SUMMARY**

The Town has undertaken another round of community consultation on the N7 beach access path upgrades concept plans and is requesting the Committee to endorse this feedback, and recommend proceeding to detailed design and documentation to Council.

#### **BACKGROUND**

Following community consultation undertaken earlier this year, the Beach Access Path Committee made a resolution (abbreviated to only reference the relevant N7 components) as follows:

- 1. Thank the community for their submissions.
- 2. Note the community consultation feedback submitted.
- 3. Endorse the progression of the project to detailed design and documentation for all four paths, subject to the following considerations:
  - d. N7 (Grant):
    - Upgrade N7 to include steps;
    - ii. The Town of Cottesloe administration report back to the Committee on the viability of a pedestrian crossing south of the roundabout at the intersection of Grant Street and Marine Parade;
    - iii. Install two showers;
    - iv. The design outcomes should reflect the importance of local amenity in public spaces.
    - v. Retain, but relocate, the existing memorial seats near N7, rather than new benches, in close consultation with affected families; and,
    - vi. Readvertise N7 for 14 days.

As a note for N7:

The original point iv - Consider swapping the location of the bike rack and showers, was deleted for safety reasons.

Moved Cr Boulter, seconded Cr Tucak

Unanimous

Since this time, the concept for N7 was updated by Ecoscape to revise the plan to incorporate steps and two showers. This was then advertised for 14 days, via newspaper adverts in The Post and The Western Suburbs Weekly, on the Council website, and via letters to affected residents and ratepayers, as well as the Cottesloe Facebook page and email database, with submissions closing on the 16<sup>th</sup> July 2018.

# **Beach Policy**

#### STATUTORY ENVIRONMENT

Local Government Act 1995 Local Government Regulations 1996

All works in the Cottesloe Foreshore Precinct will require planning approval from the Western Australian Planning Commission (WAPC) as the land sits under the Metropolitan Region Scheme. The WAPC has been consulted and has confirmed that these works are Public Works, and therefore do not require approval from them.

#### FINANCIAL IMPLICATIONS

The 2018/2019 Budget has \$300,000 set aside for beach access path upgrades. The tender amounts that have been received are, excluding GST:

- S10 \$122,821.01
- \$12 \$173,711.89
- N6 \$85,865.65
- N7 \$201,621.89

With the changes to N7, there is likely to be a budget amendment – this is covered in the tender recommendation report.

#### STAFFING IMPLICATIONS

There are no perceived staffing implications arising from the officer's recommendation.

#### SUSTAINABILITY IMPLICATIONS

The design approach for the Beach Access Paths has covered issues such as sustainability and the long term maintenance and management of the precinct. The design will need to include selected materials that have been chosen to ensure sustainability, longevity and ease of maintenance.

# **CONSULTATION**

Beach Access Path Committee Town of Cottesloe Staff Elected Members Community Consultation

#### STAFF COMMENT

Community consultation results are presented as follows, with the following definitions:

- Objection objection to the specifics of the upgrade.
- Support with comments support with comments on the specifics.

In total, 12 submissions were received, with no late submissions. All were in support of the steps, with some objections on the specifics of upgrades at the top of the steps, or requesting an extension of the steps. One was objecting to no changes in the proposed design to N6 since the last round of community consultation. This has been included here, although the consultation was with regard to N7 only.

The following is a summary of key issues raised during the consultation:

#### Ν7

- 1. There does not need to be a crosswalk at the intersection of Marine Parade and Grant Street;
- 2. Would like to extend the ladder down to the bottom, and get rid of the log ladder, or at least reduce it;
- 3. Move seats slightly;
- 4. Include two bins, one located close to the top of the stairs;
- 5. Don't use soakwells for shower water disposal water the dunes instead;
- 6. Install more sand in one section;
- 7. Ensure steps are built on piles that extend below the level of the storm beach or limestone basement:
- 8. Objection to moving shower and bike racks; and,
- 9. Objection to all other upgrades, other than the stairs.

#### N6

- 1. Would like a shower here, or at least a shower in Grant Marine Park;
- 2. Would like steps here in lieu of a log ladder.

The Administration has reviewed these and notes the following:

- 1. The administration will report back separately on the issue of the crosswalk at N7;
- 2. The existing bin just south of this area and off the drawing will be retained so there are 2 bins in proximity to the access;
- 3. Watering the dunes with shower runoff has the potential to cause significant erosion and is not recommended; and,
- 4. As previously noted, the shower is being relocated for safety reasons, and this has a design implication that affects the location of the bike racks.

The Committee is asked to review the above feedback and attachments, and determine how they would like to proceed, in light of the community comments.
