

IN May 1696 Willem de Vlamingh left Vlieland, Holland, with three Dutch East India Co ships to look for survivors of a ship which was thought to have been wrecked on the west coast of Australia. He anchored off Rottnest and went ashore on December 31. A few days later Vlamingh sent some crewmen to the mainland, where they found traces of Aboriginals and a river with numerous black swans.

That, and much more, is known. But nobody knows exactly where they made landfall.

Cottesloe's memorial to Vlamingh is south of the Town near the Old Cable Station. But it is unlikely to have been the spot. Avoiding reefs, it's far more likely the sailors came ashore at what are now Cottesloe, or Swanbourne beaches.

What's more, in its current position the memorial is rarely visited, except by cyclists passing by. So the Council has mooted the idea



of relocating the Vlamingh Memorial to the grassed terraces immediately above Cottesloe Beach. A new plaque commemorating the explorers' landing would

also be installed. Public comment about the relocation is now invited - by Tuesday, September 9, please. If the memorial is moved, the

Residents respond to LPS3

HUNDREDS of submissions from local people on Local Planning Scheme 3 will be evaluated by Cottesloe's planners and presented to Council in the next few months.

"It's a really encouragresponse," ing said Andrew Jackson, Cottesloe Manager of **Development Services.**

"We have gone out to the community twice now, most recently in June, sending to all residents a full information package on LPS3 that included a special submission form.

Enquiry by Design

In addition to the LPS3 comments made by residents and other people with an interest in Cottesloe, Council will have the benefit of an Enquiry by Design (EbD) which is planned for October. The EbD concept was

agreed between Cottesloe and the State Government's Planning Minister Alannah McTiernan to examine the contentious issues of the two hotel sites on the beachfront, a vision for the foreshore, and use of vacant railway land adjacent to Curtin Avenue in relation to density

housing, the town centre and

improving connectivity.

"It's a joint venture collaborative exercise between us and the State's Department for Planning and Infra-structure," said Andrew Jackson. "But our own staff have put in an enormous amount of time and effort to plan the EbD, because the DPI has been so short-staffed recently.

INDIANA'S PLANS GO TO THE PUBLIC

AFTER studying a new set of development proposals from the Indiana proprietors, Council has set out conditions to be met before considering them further.

The revised plans are mainly for internal works and their scope is greatly reduced from the proposal turned down by Council earlier this year.

Dates and details of the Enquiry by Design will be announced soon.

PUBLIC comments on Cottesloe's draft Natural Areas Management Plan are invited by Friday August 29.

Consultants preparing the draft were instructed to identify potential natural areas for management and provide guidelines to protect, preserve and enhance bio-diversity.

A budget allocation of

\$25,000 was made for 2008/09 and the Town is pursuing external grants to match this amount.

After public comments are received and considered, the final recommendations will be considered in the light of possible climate change scenarios. These scenarios (reported in Civic Centre News, June 2008) are part of the the Vulnerability of

Cottesloe Foreshore to the Potential Impacts of Climate Change report produced for the Town.
