# **GROYNE FENCED OFF FOR SAFETY**

**CONCERN** for public safety led to fencing the far end of the Cottesloe groyne and the whole northern side of the structure. Town engineer Geoff Trigg took the decision following the April meeting, when the Council unanimously delegated him the power to take any action needed to ensure public safety.

A full safety report will be presented this month.

#### State help

In December 2004 consultants estimated that would cost repairs \$800,000. Cottesloe has made several attempts to discuss the situation with the State's department of Planning and Infrastructure. The Council cannot afford



to make such repairs and considers the groyne a regional facility that should be supported with State funds.

Last month the Mayor requested a meeting with

#### **Station Street**

In March we asked for comments on redevelopment of Station Street. Many useful submissions were received. The outcome, decided at the April 26 Council meeting, was to NOT seek tenders at this time. Instead, the matter will be considered as part of Cottesloe's Town Centre Revitalisation Study.

#### Artworks

An amended artworks acquisition policy has been adopted. Under the policy, the CEO may approve purchases, following advice from an Arts Acquisition committee, and in consultation with the Mayor and chair of the Works and Corporate Services committee.

#### **Design Advisory Panel**

Council deferred adoption of the Design Advisory Panel policy to allow for the consideration of a late submission.

(Householders in Eric Street have already been

consulted over the proposed diversion of stormwater to the Railway Street road reserve. This limited consultation was necessitated by exploratory work on the Eric Street road reserve to find any underground rock or limestone outcrops which would increase project costs.)

Oldham's pond needs – your 'original' plants

**RESTORATION** of the picturesque water garden

PETITION COUNCIL received a petition, bearing 3,706 signatures, asking the Town 'not to allow any building development in the Marine Parade precinct (west of Broome St) which exceeds a

height of 12 metres above natural ground level. Roughly half the signatories lived in Cottesloe and other western suburbs. The Council has asked solicitors handling the State Administrative Tribunal review on the Cottesloe Beach Hotel development application refused by Council to take the petition (and another received in December 2004) into account and bring them to the attention of the SAT.

gateway between the western suburbs and the City of Perth, according to the plan. Key objectives include improved pedestrian access and safety; encouragement of public transport use; and maximised beautification and enhancement through landscaping, including tree planting.

Before signing off on the visionary plan, which has been driven by WES-ROC, Cottesloe Council wants comments from Town residents (by Monday June 13.) When finalised the Revitalisation Plan will be the subject of a presentation meeting with the State Minister for Planning and Infrastructure.

THREE years ago a survey of 358 local people, all electors of the Town and selected at random, gave the Council a valuable guide to community attitudes and satisfaction. It asked for their opinions on the whole range of services provided by the Town.

Well, here it comes again! "By issuing what is basically the same survey, in exactly the same manner, we can discover how community use of, and attitude to, services has changed," said CEO Steve Tindale. "This will give a measure of our effectiveness over recent vears.'



Cost of making the survey is kept low. Staff handdeliver most of the forms; a few are posted.

Minor changes have been made to the 2002 service list to include certain developments. But everything from A - Aged Persons Support Service; to V - Visual Privacy Controls is included for evaluation.

The surveys will be distributed this month.

at the Civic Centre entrance will return it to the original style of more than 50 years ago.

Designer of the Water Garden, opened on Arbor Day, 1962, was landscape architect John Oldham. Local plants, many of them succulents, were part of his plan. But since then the area has been invaded and dominated by cotton palms which are now reaching the end of their life-span.

The Town is taking the opportunity to revert to the original plan.

"We would love to hear from local people whose own gardens may harbour similar plants to those used by Oldham, and who might like to contribute some to the project," said Alan Lamb, co-ordinator of the restoration.

PUBLIC consultation over bus shelters was announced in February. Although only one resident responded, Council has decided to replace three old shelters on Marine Parade, Grant Street and North Street provided funds are available in the 2005/2006 budget.



COTTESLOE Playgroup (Inc) will use a \$6,700 Council grant for fence replacement and rubber playground surfacing. This not-for-profit organisation, based in Railway Street, provides 10 playgroup sessions a week largely for local families. Modest annual family membership fees cover operational costs but leave little surplus for improvements. The Council's donation will be made from the 2005/2006 budget.
