7 ITEMS FOR DISCUSSION

7.1 ACROD Bays – 2021/22 installations/upgrades

- 2020-21 program complete (Vlamingh to complete once work in the area is done).
- Suggested future bays:
 - Main Foreshore (Shaun advised dependent on future improvements)
 - There is room and need for another one at the Groin
 - More bays at the end of Forrest St to improve access to the foreshore
 - Enquiry about bays near Cott medical centre (possible location if there are none).
 - Query requirements for parking outside new developments 120 Marine Parade and OBH – refer to Planning
 - Request for CEO to refer to PROCOTT – they may have suggestions, if not an ACROD bay possible short term parking (10 minutes i.e. collect and go)

7.2 Safe Crossings

- Slowing measures needed for crossing Broome to Forrest and John Sts
 - Noted speeding vehicles
 - Dangerous crossing anywhere there not on the crest
 - Possible installation of speed cushions like Eric St (but lighting would need to be considered if this occurred)
 - Need to address issues outside the Civic Centre
 - Raised at 9.2 – Attempting to cross Railway St (@SHINE), very difficult (and dangerous) to navigate.

7.3 Disability Awareness Training

- Working with or alongside people with disability
 - Include working with those who have an intellectual disability, autism, mental health (encourage understanding of these)
- Possibly an opportunity to collaborate with Mosman Park and Peppermint Grove
- Provide opportunity for staff to learn about the services available from Shine and Curtin Living – create awareness of what's out there.
- Attempt to increase EM attendance to promote understanding (after next election)

- Close the loop with Anna's story (newsletter) – update where she is and how her time with the Town facilitated that.

7.4 IDPwD – 3 December 2021

- Possibly recreate last year's event along the newly completed section of the PSP
 - Could include other groups – make contact with disability cycling groups re: tandem cyclists/hand cyclists
 - Also possibility to use and promote the trishaw

7.5 Membership - Universal Access and Inclusion Community Reference Group

- Opportunity to increase membership after the elections – room for 2 more community members – group to advise Jodee if they know of anyone
- Group support the funding of 1 Auslan interpreter for meetings to allow Jenelle to attend. Cr Sadler confident that there is support for Jenelle at the meetings, they always work to accommodate everyone's needs and will adjust pace as required.
 - Possibly look into an opportunity to provide a shared Auslan service with Mosman Park and Peppermint Grove through the library
 - Shane to take to Grove Library meeting
 - Possibly look into investigating if Shenton Park College can provide someone from their Auslan teaching pool or an interested parent versed in Auslan.

- Cr Sadler request: Liaison with Jodee RE: Grant Funding - awareness Town does not always know what's out there.
 - Western Suburbs low rate of accessing support

- Low disability numbers in the community but high number of visitors with disabilities to the area

- Chris advised there may be opportunity to explore providing a 'Community Hub' (M.A Community Engagement Team) – highlighting the higher rates of undiagnosed disabilities – intellectual, autism and mental health and the services that are available.

9.2 Wearne Cottesloe (Curtin Heritage Living)

- Update – Curtin Heritage now has an agreement with SHINE and will be able to provide improved services to the community.
