

## INTERSECTION OF CURTIN AVENUE AND FORREST STREET, COTTESLOE

I refer to your submission of 7 May 2012 seeking Main Roads' Agreement in Principle to install the new traffic signals at the above location.

I am pleased to advise that 'Agreement in Principle' has been given by Main Roads to install pedestrian activated traffic signals (pelican crossing) on Curtin Avenue south of Forrest Street in Cottesloe.

Please note this agreement is conditional and allows Council to further develop the project to final design. The agreement does not guarantee the modifications will proceed without;

- Demonstrating all necessary conditions can be satisfied. These conditions include but are not necessarily limited to:
  - Determine the preferred system of traffic signal operation.
  - Design the road layout indicating lane configurations for the preferred system of signal operation.
  - Main Roads approval of the design of the road layout, traffic signal phasings and layout and signing and pavement marking layout.
  - Provision of the specifications and software documentation.
  - The entire project to be fully funded by Council or Council's black spot submission.
  - Any other supporting data as necessary.
- 2) Council obtaining formal approval from Main Roads to the installation of the traffic signals, given formal approval being granted the Council will be required to;
  - Arrange the modifications of the traffic signals and associated works, including its software and required signing and pavement markings in accordance with Main Roads requirements.
  - Following installation, arrange handover of Main Roads Infrastructure to the relevant Main Roads Contractors and forward the associated completed documentation.

This Agreement in Principle allows Council to further develop the proposal, including detailed design and community consultation, before submitting it to Main Roads for its consideration and final approval.


