## 4.2 "Icarus4" Location

At the December 2016 Council meeting, Council resolved to accept the donation of a sculpture. The Council Report is attached to this agenda. The Committee is to consider a location for the donated sculpture entitled "Icarus 4". This sculpture is to be placed in the general vicinity of the Marine Parade and Grant Street intersection.

The Donor would like to install the sculpture in late March to commemorate the loss of a family member. The sculpture has been valued at \$35,000 by a licensed valuer.

The Town of Cottesloe would be required to maintain and insure the sculpture under the terms of a yet to be finalised Deed. Engineering certification of the installation may be also required which would be at the Council's expense. Depending on the final location chosen, The Town of Cottesloe would be required to liaise with Coast Care and other partners to insure there is no damage made to the environment, i.e. coastal dune during installation and subsequent maintenance.

- 2. Further if this site proves to be unsuitable, the sculpture is to be located on the grass area to the north of the dune.
- 3. That nearby residents be informed of the proposal, after consultation with Cottesloe Coast Care Inc. and the final site determined.
- 4. That the artists responsible for the nearby sculptures, "Untitled" and "Relationship: Together Series", be advised of the Committee's decision.
